ZAYAS SEIJO, MAYOR OF THE AUTONOMOUS MUNICIPALITY OF PONCE OR HIS AUTHORIZED REPRESENTATIVE, TO SUBMIT THE ANNUAL CONSOLIDATED ACTION PLAN OF THE FORMULA GRANT PROGRAMS, AMENDMENTS THERETO AND ASSURANCES CONTAINED THEREIN, TO THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT AND FOR OTHER PURPOSES.”**

**WHEREAS:** In accordance with the U.S. Department of Housing and Urban Development’s regulations, the jurisdictions are required to submit an Annual Action Plan that serves as a planning document and an application for funding under any of the Community Planning and Development Formula Grant Programs, CDBG, ESG, HOME AND HOPWA;

**WHEREAS:** The Autonomous Municipality of Ponce, as an entitlement city, received a notification of a consolidated formula allocation from the Department of Housing and Urban Development for the fiscal year 2007-2008 amounting to **\$6,964,305.00** of which **\$5,295,867.00** are from CDBG, **\$1,439,026.00** from HOME, and **\$229,412.00** from E.S.G., Programs for which an Annual Action Plan must be submitted on or before May 15, 2007.

**NOW THEREFORE: BE IT RESOLVED BY THE LEGISLATURE OF THE AUTONOMOUS MUNICIPALITY OF PONCE, PUERTO RICO:**

**SECTION ONE:** That the Mayor of Ponce or his authorized representative, is hereby designated as the official representative of the Autonomous Municipality of Ponce, and as such, is authorized to submit the Annual Action Plan of the formula grant programs CDBG, HOME and E.S.G. and for other purposes.


**SECTION TWO:** That the Mayor of Ponce or his authorized representative, is authorized and directed to execute any contract and/or agreement with the U.S. Department of Housing and Urban Development and to request and expend the funds pursuant to said contract and/or agreement.

**SECTION THREE:** Any Ordinance, Resolution or part thereof which may be in conflict with this Resolution is hereby repealed.

**SECTION FOUR:** This resolution shall take effect immediately upon its approval.
