"RESOLUTION OF THE MUNICIPAL ASSEMBLY OF
PONCE, PUERTO RICO AUTHORIZING THE MAYOR
OF PONCE TO BE THE OFFICIAL
REPRESENTATIVE OF THE MUNICIPALITY OF
PONCE AND AS SUCH, TO SUBMIT THE FINAL
STATEMENT OF COMMUNITY DEVELOPMENT
OBJECTIVES AND PROJECTED USE OF FUNDS,
AMENDMENTS THERETO AND ASSURANCES
CONTAINED THEREIN, TO THE DEPARTMENT OF
HOUSING AND URBAN DEVELOPMENT AND FOR
OTHER PURPOSES."

WHEREAS: The primary objective of Title I of the Housing and Community Development Act of 1974, as amended and of the Community Development Program of each grantee under this Title, is the development of viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income; and

WHEREAS: Said Act authorizes the Secretary of Housing and Urban Development to provide grants to units of general local governments to help finance Community Development Programs;

WHEREAS: The Municipality of Ponce received a community Development Block Grant notification for fiscal year 1992 amounting to \$8,348,00 for which a Final Statement of Community Development Objectives and Projected Use of Funds must be submitted no later than May 29, 1992;

WHEREAS: Eligible applicants, in this case the Municipality of Ponce, are required to adopt an official act or resolution designating an official representative to submit the Final Statement of Community Development Objectives and Projected

Use of Funds, amendments thereto and all understandings and assurances contained therein and to act in connection with the submission of the Final Statement and to provide such additional information as may be required;

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL ASSEMBLY OF PONCE, PUERTO RICO:

SECTION I: That the Mayor of Ponce is hereby designated as the official representative of the Municipality of Ponce and as such, is authorized to submit the Final Statement of Community Development Objectives and to provide such additional information as may be required.

SECTION II: That the Mayor is authorized and directed to execute any contract and/or agreement with the U.S. Department of Housing and Urban Development and to request and expend the funds pursuant to said contract and agreement.

SECTION III: Any ordinance, resolution or part thereof which may be in conflict with this resolution is hereby repealed.

SECTION IV: This Resolution shall take effect immediately.
