"RESOLUTION OF THE MUNICIPAL ASSEMBLY OF PONCE, PUERTO RICO AUTHORIZING THE MAYOR OF PONCE, PUERTO RICO, TO FILE AN APPLICATION WITH THE U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, UNDER SECTION 119 OF THE HOUSING AND COMMUNITY DEVELOPMENT ACT OF 1974, AS AMENDED, AND AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH SAID AGENCY AND ACCEPT AND RECEIVE THE GRANT AND FOR OTHER PURPOSES."

WHEREAS: Under Section 119 of the Housing and Community Development Act of 1974, as amended, the Secretary of the U. S. Department of Housing and Urban Development is authorized to make Urban Development Action Grants (UDAG) to cities and urban counties which are experiencing distress, to help stimulate economic development activity and aid in economic recovery;

WHEREAS: Under said legislation eligible applicants in the case of municipalities are required to authorize by resolution the Chief Executive Officer, to file an application and enter into an agreement with the U. S. Department of Housing and Urban Development, receive and expend the grant, and provide the necessary assurances and certifications;

WHEREAS: The Municipality of Ponce is interested in applying for an urban Development Action Grant amounting to **FOUR MILLIONS, NINE HUNDRED SIXTY SIX THOUSAND TWO HUNDRED FORTY THREE DOLLARS (\$4,966,243.00)** for the development of housing projects at Los Meritos Sector in Playa Ward and at former Dr. Pila's Hospital, improvements to infrastructure at La Guancha and improvements to streets at Historic Zone.

NOW THEREFORE: BE IT RESOLVED BY THE MUNICIPALITY ASSEMBLY OF PONCE, PUERTO RICO:

SECTION ONE: That the Mayor be and is hereby authorized to execute and file an application and/or amendments thereof on behalf of the Municipality of Ponce, with the Department of Housing and Urban Development, for a grant pursuant to Title I of the Housing and Community Development Act of 1974, as amended for the development of the aforementioned projects.

SECTION TWO: That the Mayor of Ponce, is hereby authorized and designated as the Municipality's representative and as such to act in connection with the application or any agreement, provide all required understandings, assurances and certifications, and comply with the regulations pertaining to the UDAG Program and the law that governs said program.

SECTION THREE: That the Mayor is hereby authorized and directed to execute any contract and/or agreement with the U. S. Department of Housing and Urban Development, and request and expend the grants pursuant to said contract.

SECTION FOUR: That the Mayor or his duly authorized representative is authorized to sign and execute any public deed related to this Resolutions.

SECTION FIVE: Any ordinance or Resolution or parts thereof which may be in conflict herewith is hereby repealed.

SECTION SIX: This resolution shall take effect immediately upon its approval.
